- *Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- *It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.
- *Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- *Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Any illegible or incomplete entries will not be entered in the trial.
 - A withdrawal from the trial after closing date due to an injury and/or illness to the dog or for bitches which come into season after the closing date will be eligible for a refund of 75% of the total entry fee paid. A letter from your veterinarian is required.

Site Information

- 5 mph speed limit on the property. Violators will be asked to leave the trial site and no refunds will be issued.
- Tetz Lane is posted 30 mph. It is strongly suggested that you go no faster than 10mph between the white house on the turn and the first red barn.
- Crating is not permitted in the seating area of the arena, but there is availability in some stalls. It is also convenient to work from your car, and there is plenty of room to tent/crate outside in designated areas.
- Park only in designated areas as directed by trial officials. Do not block RV's.
- Please stay close to the barn. The fields, areas by the houses, and fenced runs in front of the building are all off limits.
- All dogs must be on leash and under control at all times except when using the warm up area or in the agility ring.
 Unattended dogs in stalls must be contained in crates or ex- pens. No flexi leashes in extension allowed inside the barn or arena.
- No food, toys, clickers, or other aids or devices shall be permitted on the course or within ten feet of the ring at any time, exception for toys used for Declared Training in the Ring.
- No clickers or squeakers to be used anywhere in the building.
- No unsupervised children shall be allowed on the premises.
- Consumption of alcoholic beverages is not permitted during trial hours.
- No smoking in or within 50 feet of any building.
- No heaters allowed in stalls except with express permission of the Board.
- You must clean up after your dog and place waste in the receptacles provided. Failure to do so may lead to being excused from the trial.
- Absolutely NO food or treats are to be left in the arena or the stalls overnight.
- All trash is to be placed in proper receptacles: black/garbage and blue/recycling.
- Onsite water is NOT potable. Please bring drinking water for yourself and dogs. (Available bottled water for volunteers only no water available for dogs.)
- No food vendor on site please come prepared.
- Self-contained camping only/ limited number/ preregistration required.
